PROCEDURE FOR BUYING

- The attached worksheet should be completed for your Purchaser. Completed worksheets should be e-mailed to <u>frances@spectrumrealtyservices.com</u>
- 2. We start accepting worksheets on August 28th, 2021.
- 3. Each worksheet must be completed in full with Purchaser's full contact information including telephone number, e-mail address, occupation, name of employer, etc. And must be accompanied by a clear colour copy of the Purchaser's valid Government issued photo I.D.
- 4. You will be contacted by telephone to confirm you client's lot selection, at which point, an appointment will be arranged to meet with you and your clients for signing. Virtual or In Person Appointments will be available.
- 5. If you would like to bring your client to the sales office, an IN PERSON will be scheduled, only 3 people can be present for the appointment. 2 Clients and Co-Operating Agent, no children or other family members will be permitted in the sales office.
- 6. At time of signing the Agreement, the Purchaser must provide all post-dated deposit cheques, including the Initial deposit cheque of \$20,000.00 in the form of a Bank Draft, to be made payable to the Vendor STERLING HOMES (WESTBURY RD) INC. If the Agreement is done virtually, the Purchasers must drop off post dated cheques at the sales office, for the further deposits the next day.
